

## **VPK School Year Staff Requirements**

### **VPK Director**

**Qualifications & Supporting Documents:** 

- A current <u>Clearinghouse Background Screening</u> with an "Eligible" status for the DCF General and Child Care items.
- An Affidavit or Attestation of Good Moral Character Form with all required fields completed.

□ A current <u>VPK-Endorsed Director Credential</u> proven through a DCF transcript.
 □ A valid Educational Leadership Certificate issued by the Florida Department of Education.

General Responsibility: The VPK director oversees VPK administration and instruction. They must be onsite for the majority (at least 51%) of the VPK program. You must have a qualified VPK director to start your VPK program. If you lose your VPK Director or if there is a lapse in credential after the program begins, notify ELCAC to receive guidance on submitting a replacement or obtaining a provisional status.

#### **VPK Lead Instructor**

**Qualifications & Supporting Documents:** 

- A current <u>Clearinghouse Background Screening</u> with an "Eligible" status for the DCF General and Child Care items.
- An Affidavit or Attestation of Good Moral Character Form with all required fields completed.
- Completion of the DCF course called "Implementing the Florida Standards in Preschool Classrooms: 3 Years Old to Kindergarten" (VFSP or SPC3TK)." This must appear on the DCF transcript.
- Completion of 3 approved 5-hour emergency literacy courses (or 1 of the approved 20-hour courses) from the "VPK Lead Teacher Emergent Literacy Requirement DEL Flyer." There are only 3 emergent literacy courses from this flyer that are fully online: Emergent Literacy for VPK Instructors (VPK21), Language and Vocabulary in the VPK Classroom (LVPK21) and Building a Strong Foundation for Emergent Literacy (VIEL). The other options require in-person and virtual instructor-led components which take longer to complete. Once this requirement is met, the EMERGENT LITERACY REQUIREMENT section at the bottom of the DCF transcript will show "Yes" with effective and expiration dates.
- A current <u>Staff Credential</u> indicated as FCCPC, NECC, or Formal Education on the DCF transcript.
   If it is not on the DCF transcript, you may upload a diploma or college transcript as proof of a <u>degree in an approved field</u>.

General Responsibility: The VPK lead teacher conducts VPK instruction based on Florida Standards and age-appropriate curricula (<a href="http://www.floridaearlylearning.com/vpk/vpk-providers/resources">http://www.floridaearlylearning.com/vpk/vpk-providers/resources</a>) to prepare four- and five-year-old children for Kindergarten. Each VPK classroom must have at least one qualified VPK lead teacher.

# VPK School Year Staff Requirements

**VPK Aide** (also known as an "assistant teacher")

**Qualifications & Supporting Documents:** 

- A current <u>Clearinghouse Background Screening</u> with an "Eligible" status for the DCF General and Child Care items
- An Affidavit or Attestation of Good Moral Character Form with all required fields completed.
- No credential required.

General Responsibility: The VPK assistant teacher supports the VPK lead teacher in the VPK classroom during the entire instructional period (they are not a floater or substitute). It is *optional* to have a VPK assistant teacher, but one of the benefits is that it will increase the maximum number of students allowed in the VPK classroom (refer to the section below named "VPK School Year Ratio").

### **VPK Substitute**

**Qualifications & Supporting Documents:** 

- A current <u>Clearinghouse Background Screening</u> with an "Eligible" status for the DCF General and Child Care items.
- An Affidavit or Attestation of Good Moral Character Form with all required fields completed.
- One of the following credentials:

General Responsibility: The VPK substitute can assume the lead or aide role when they are not on the premises. It is highly recommended to assign at least one qualified substitute to your VPK school year program to remain in compliance when the lead or aide is absent. You cannot use a substitute that has not already been approved in your VPK Application. You must also track your VPK substitute usage as they can only be used for 30% of the entire 540-hour program. If you have a substitute that does not have any of the above credentials, that is considered a "substitute assistant" and they can only assume the VPK aide role (they would not qualify to substitute for the VPK lead).

<u>VPK School Year Ratio</u>: If there is one lead teacher in the VPK school year classroom, the highest acceptable teacher-to-child ratio is 1:11 (this includes non-VPK students in the classroom and is limited to the room capacity). If there is one lead teacher with an aide or two lead teachers in the VPK school year classroom, the highest acceptable teacher-to-child ratio is 2:20 (this includes non-VPK students in the classroom and is limited to the room capacity).
